SPEAKERS' PROFILE

Angela McGowan is an office manager within the National Probation Service. She supervises 9 administrators, and is responsible for the day to day running of the office. She is also a qualified Unison H&S rep, a Black and Asian Support Group rep and a Diversity Champion, of which is how "I came to meet Ruth". The Diversity Champion role requires her to liaise with the community to create better working relationships and introduce all to the Criminal Justice System. Through this role, she has made many friends and established good working relationships with several groups/communities within the borough of Barnet and hope to continue to help to strengthen this.

Elizabeth Kayembe is the Executive Officer at the AFRICAN WOMEN'S WELFARE ASSOCIATION (AWWA). Besides overseeing the domestic violence project, Elizabeth's remit is to provide advocacy and counselling services for African women and children in the community. She also manages staff and volunteers who carry out the outreach and befriending services of the organisation and is responsible also for the fundraising activities of AWWA. She specializes in awareness training and empowerment for women and children. For the past two years, Elizabeth has worked on issues around domestic violence in the African community and she feel very strongly about a holistic approach to preventative work in this area. Elizabeth is currently undertaking a Doctoral degree in translation studies at University of London, Birkbeck College. She completed her MPhil degree or DEA, (Diplôme d'Etudes Approfondies) in translation and terminology at the Université Lumière Lyon II, France in 1998.

As a qualified postgraduate in pedagogy, Elizabeth has used her experiences from lecturing at the university and training various communities both at grassroots and organizational levels for over 10 years to equip various communities with skills for sustainable development. She is passionate about gender mainstreaming not only at the level of biological differentiation, but also at the level of race.



Fiona Macaulay works as Project Worker for the Information Service at the Bristol Crisis Service for Women. She has experience in research, mental health support and writing and designing information for different groups of people in a number of formats. This experience has enabled her to effectively produce and disseminate information about self-injury for specific groups of women since joining BCSW in 2004. She consulted widely with organisations to produce information for women from black and minority ethnic groups about self-injury and has recently worked with women in prison to produce a self-help book women in prison can keep in their cell.'

Esther Stanford who trained as a barrister at Inns of Court, School of Law, Holborn, describes her vocation as a critical legal activist consultant, specialising in human and people's rights. Esther has always believed that her principle mission in life is to make a positive difference to those around her, her community and in the world. She is renowned for her holistic Community law practice. She has developed specialist advocacy and legal literacy services in the arena of child protection, mental health and youth justice. As Convenor of FAADAR, the Forum of Africans and Africans Descendants Against Racism, she has an extensive experience of community mobilisation for implementation of a race based policy framework with international significance. Esther is a researcher and legal activist on Pan African Reparations for historical and contemporary injustice. She is currently developing a community development programme to redress the harmful effects of traumas associated with internalised racism and gender oppression. Most significantly, she is an advocate for the recognition of AFRI-PHOEBIA (Anti -African Prejudice and Discrimination) post-traumatic slavery syndrome within human service professions.

Caroline 'Shola' Arewa specialises in Health and Success. She has an extensive background in Humanistic Psychology, Yoga, Holistic Healthcare and Training and is known for her gentle yet powerful style developed over twenty years of helping people make important life changes.
